The undersigned further agrees to pay interest at the rate of one and one-half percent (1 ½ %) per month, (18% per annum) commencing the first day following the due date. We reserve the right to charge interest for invoices past due for more than 30 days. In the event of having to provide copies of misplaced invoices we will charge \$1.00 for each copy in excess of 10 copies.

In consideration of the extension of credit by the Seller herein, to Buyer herein, the undersigned does jointly and severally personally guarantee to pay and be responsible for payment of all sums, balances, and accounts due Seller by Buyer, including collection charges and/or attorney's fees. This shall be an open and continuing guarantee and shall continue in force notwithstanding any change in the form of such indebtedness, or renewals or extensions granted by Seller, without obtaining any consent hereto and until expressly revoked by written notice from me/us to Seller.

Any such revocation shall not in any manner affect my/our liability as to any indebtedness existing prior hereto. I/we do hereby waive notice of the acceptance of this agreement, notice of default or non-payment and waive action by required by any statute, against the Buyer. No delay on Sellers part in exercising any right hereunder, or taking any action to collect or enforce payment of any obligation hereby guaranteed, either as against the Buyer or any other person primarily or secondarily liable with the Buyer, shall operate as a waiver of any such right or in any manner prejudiced Sellers rights against me/us. I/we agree that in the event of any default at any time by said Buyer, Seller shall be entitled to look to me/us immediately for full payment, without prior demand or notice.
